

# MINUTES

## County Council Meeting

### Special Meeting

**Tuesday, August 24, 2021**

Spartanburg County Council met on Tuesday, August 24, 2021, at 2:00 p.m. in County Council Chambers of the County Administration Building. The following were in attendance: Honorable Manning Lynch, Chairman; Honorables Monier Abusaft, Jack Mabry, David Britt, Justin McCorkle, and Jessica Coker, Council Members; along with Cole Alverson, County Administrator; Earl Alexander, Deputy County Administrator; and John Harris, County Attorney. Honorable Bob Walker, Council Member, was absent. In compliance with the Freedom of Information Act, notice of this meeting was provided in advance to the local news media and other interested parties.

Meeting was live streamed via YouTube. Links and instructions for how to access this meeting via computer or mobile device were made available on the County's webpage and provided to the local media.

- I. Chairman Lynch called the meeting to order.
  
- II. Motion made by Ms. Coker to render third reading to an Ordinance to provide for the issuance and sale of not exceeding thirty million two hundred sixty thousand dollars (\$30,260,000) **Spartanburg County, South Carolina General Obligation Bonds**, in one or more series; to prescribe the purposes for which the proceeds shall be expended; to provide for the payment thereof; and other matters relating thereto. Motion seconded by Mr. Mabry and carried.
  
- III. Motion made by Mr. Britt to render second reading to an Ordinance to amend the Agreement for Development for Joint County Industrial Park by and between Spartanburg County and Cherokee County, South Carolina, so as to include additional property in Spartanburg County as part of the Joint County Industrial Park, and other matters relating thereto. **(AGA Tag Solar II, LLC; RG Frontage, LLC; JSD Flatwood PV-1, LLC; The Cubes at Fort Prince, LLC; Fort Prince Logistics, LLC; and SC Global Logistics, LLC)** Motion seconded by Mr. Mabry and carried.

- IV. Motion made by Mr. Britt to render second reading to an **Ordinance to repeal Ordinance O-05-17, which established a Uniform Road Maintenance Fee** for Spartanburg County Transportation Infrastructure. Motion seconded by Mr. Mabry and carried.
- V. Motion made by Mr. Britt to render second reading to an **Ordinance amending the Spartanburg County Performance Zoning Ordinance (PZO)**, Ordinance No. O-19-29, so as to provide additional options for acceptable Architectural Design Building Materials. Motion seconded by Mr. Mabry and carried.


